Together on Country (TOC) Program projects are a two-step application process. Interested applicants can submit an EOI. Applicants who are successful through the EOI assessment component will then be invited to develop their EOI into a full Project Proposal. Approved Project Proposals then move into the implementation stage.

LALCs are only permitted one successful TOC Project. However, LALCs that were unsuccessful in their first TOC EOI will receive constructive feedback and be encouraged to re-apply.

PROJECT ELIGIBILITY

All LALCs* are eligible for the Program and EOIs are open all year. Eligible projects should contribute to the improvement of waste management practices on LALC owned land in NSW. They should address various sources and types of waste and align with the waste management priorities of the Community.

Projects need to be completed within **18 months of receiving formal project approval**.

EOI's will be considered until April 2027 or until funding is exhausted (whichever comes first).

*LALCs currently under administration are ineligible - please contact NSWALC's Program implementation Unit team on details above for further information.

Items that can be funded under the program

- Illegal dumping deterrents including equipment and/or infrastructure.
- Equipment and/or infrastructure for business-as-usual waste services.
- Waste clean-up and disposal activities including waste audits, wages for community members to perform clean-up work or funding to engage specialists to perform removal or remediation works.
- Training, education, and communication initiatives that relate to waste management within the community.
- Project investigation and planning.
- Business partnerships and action to support circular economy.
- Other items as agreed by the EPA and SWALC where they meet the outcomes of approved project plans.
- Projects incorporating the removal of dumped asbestos will be considered on a case-by-case basis.

Items that cannot be funded under the program

- Activities/items not aligned with approved project activities or the program objectives.
 - Vehicles, except for vehicles where the sole use is for waste management activities.
 - Core operational expenses such as rent, electricity, and internet.
 - Contaminated land rehabilitation.
